AAPS IS REGISTERED AS A CHARITY WITH THE AUSTRALIAN CHARITIES AND NOT-FOR-PROFITS COMMISSION (ACNC). ELIGIBLE TAX-DEDUCTIBLE DONATIONS HAVE DEDUCTIBLE GIFT RECIPIENT (DGR) STATUS WITH THE AUSTRALIAN TAX OFFICE.

HOW DOES IT WORK?

AAPS is registered with Good2Give. This is a user friendly online platform that allows donations to be made to charities from your salary.

Organisations and employees can sign up using the platform and can choose how often and how much they would like to donate.

WHAT DO EMPLOYERS NEED TO 00?

Companies can improve their staff participation, morale and retention by challenging their staff to participate and potentially matching employee donations, through the Good2Give platform. At the end of the financial year, you include the total amount donated in each participating employee's payment summary.

4 STEPS TO SET UP **WORKPLACE GIVING USING GOOD2GIVE**

Step 1: Contact Good2Give to set up your Workplace Giving program with AAPS.

Step 2: Offer employees the opportunity to contribute. Both organisations and individuals sign up through the platform directly.

Step 3: The payroll officer will set AAPS as a vendor. To obtain our BSB and Account number, please contact finance@aaps.org.au.

Step 4: Employee donations will be deducted from their gross salary each pay period, meaning they receive an immediate tax-saving without the need to keep records of your donations. The employer will provide details of total donations in the end of financial year PAYG Summary Statements.
